MINUTES OF THE BOARD OF DIRECTORS' MEETING

DATE: November 9, 2009

CALLED TO ORDER: By Kevin Anderson at 7:30 PM

PLEDGE: Jim Clark led the pledge to the flag.

ATTENDANCE: President – Kevin Anderson; Vice President - Mike Anderson; Treasurer – Tammy

Thomas; Secretary - George Washnak; along with 15 other delegates and four guests. Total number in attendance was 24.

INTRODUCTION OF NEW DELEGATES AND GUESTS: Jack Marvin and Mike Thrall attended as representatives of Brentwood Rod & Gun; Jim Clark the USI NRA chairman was present; and Kevin introduced Brent Basilico the attorney for USI.

MINUTES OF PREVIOUS MEETING: The minutes of the October 2009 meeting were approved as submitted.

TREASURERS REPORT: Tammy Thomas – Financial reports for the month of September 2009 were distributed and discussed. The report showed a \$10,000 profit for the month.



INFORMATION FROM THE CHAIR TO THE BOARD:

1. Brentwood Rod and Gun Club: The attorney for USI, Mr. Brent Basilico, will present updated information on the USI Articles of Incorporation, Bylaws; and the Membership Purchase Agreement under Old Business.
2. Five Stand Project: The project is finished. The roofing, painting, doors and all trim is completed. The workmanship is excellent.
3. Skeet House and Trap Projects: All trap and skeet projects have been completed. Doors were installed, painted, and locks were installed. The old door keys will not work. If you have an old key, you will need to obtain a new one from Steve McConnell.

4. Rifle & Pistol Range: The R/P Range cash register was checked and the credit card module was found to be in working order. It appears to be a data line problem. Steve McConnell will have it corrected as soon as possible.
5. USI Web Site: Manuel Newman has updated the site. This is a "work in progress". The "draft" website unfortunately was focused wholly on Diablo Rod & Gun, and not USI. I have provided Manuel with some guidance as to what USI expects from our corporate web site. While the site is being revised, we have reverted back to our existing web page.
6. Our attorney, Brent Basilico, of Sellar Hazard Manning Ficenec and Lai is present to discuss the draft changes to the USI Articles of Incorporation, Bylaws; and the Membership Purchase Agreement with Brentwood Rod & Gun.

COMMITTEE REPORTS:

Trap/Skeet and Pullers – Steve McConnell – No report.

Rifle/Pistol – Dave Agazzi – In October there were 1,601 Shooters; 51% were members.

L.E.T./Hunter Ed. Bldg/NRA Training – Jim Endress – there were 16 billable hours last month, and 58 hours are scheduled for this month so far. The NRA insurance premium information has been received but it appears that are no group policies available to USI that would cover individuals who are paid to provide training. So far Jim has only seen policies that each instructor could purchase individually.

Multi-Purpose Range: John Labash advised the schedule was full, there were no issues.

Archery Range: John Labash advised that the range is operational.

Grounds/Equipment Maintenance/Club House – Steve McConnell –no report.

Action Pistol – Jim Endress for Bruce Fitch - The November Orientation Class is full. Since the last meeting we've conducted 2 USPSA matches, 1 IDPA match, and a Steel Challenge match.

Environmental – Kevin for Robin Wendt – Soil samples have been taken and we are awaiting the results.

Hunter Education – Jim Clark - During this past year, 12 classes were held; 6 conventional classroom courses and 6 On-line courses. 176 students attended with a 96% passing rate. By comparison, in the prior year 10 classes were held with 161 attendees with a 93% pass rate. Jim has released the 2010 schedule for the 12 classes (6 conventional : 6 on-line).

Youth Programs – Rod Guyette submitted his report by e-mail - there was no activity with Mike Lilygren's monthly USI youth shoots; there were two Diablo Musketeer shoots; 62 youths and 3 adults participated in the USI youth shotgun program; and the Contra Costa 4-H Club held no shoots in October. Boy Scout Troop 202 of Walnut Creek has requested that we hold a shotgun event for there 20 youth members, aged 11 to 14. We are trying to accommodate them.

Webmaster: Manuel Newman - no report.

OLD BUSINESS: USI's attorney, Brent Basilico esq., presented and the delegates discussed the draft Amendments to the USI Articles of Incorporation with him. Next, the draft proposed Membership Purchase Agreement between USI and Brentwood Rod & Gun was reviewed and discussed; and finally the draft Amended Bylaws were discussed. It was determined that significant changes to this last draft document were required. Our attorney is to make the suggested language and content changes, and then e-mail the updated version of the drafts to Kevin Anderson who will distribute them to the

delegates. Any further comments or suggested changes by the delegates are to be sent to Kevin who will coordinate submitting them back to our attorney.
